#### **REPORTS**

- **❖ Student Report** − Camille Bagnani
  - The new trimester started about two weeks ago
  - Finishing up an art craft in advisory. Each advisor group made a bird that stop at Great Salt Lake on their long journey. While at the Great Salt Lake, these birds eat and grow doubling in size. The concept was that the birds were the students gaining knowledge at NDPA on their long journey of life.
  - New school hoodies that have "if you can dream it you can do it" on the sleeve in Spanish.
  - Basketball season started today. We now have a student section to promote school involvement.

- ❖ Audit Report Ken [Eide Bailly] passed out a letter to all board members and briefly reviewed the required letter that explains their findings. Debby asked if it was prudent to have the board hire an independent auditor to come in and audit the schools book. There was a discussion on the Government Auditing Standards and Generally Accepted Accounting Principles. Ken explained that every year they choose a different area to audit that isn't normally audited. Ken reviewed the school's FY 2013 financial statement and the three audit opinions that were issued by Eide Bailly. There was a discussion on the building payment and the building maintenance account. Ken stated that the school had a clean audit. Ken disclosed that he has children that attend NDPA.

#### **❖ Principal Report** – Debby Gomberg

- October 1 final count was 1,008. Debby learned that because of two new area schools families were signed up for more than one lottery.
- Debby reviewed the Standard & Poor's bond rating report. It was a very good report. We still have a BBB- rating which is the lowest rating for an investment grade bond. S & P considers our school to be sustainable. There was a discussion on the debt burden.

- ❖ <u>Discuss and Vote on Amended 2013-2014 Annual Budget</u> Debby briefly reviewed the amended budget as of November 15<sup>th</sup>. She handed out an updated page 12 since it was a incorrect. The budget in the packet showed that we have 1,007. We actually have 1,008 students plus Ryan added tick marks that show the changes in this budget. Ryan reviewed the changes to the general budget sheet. The majority of the money due to the increase of additional students is going to surplus. Jennifer Bazzano made a motion to approve the amended 2013-2014 annual budget. Motion passed unanimously.</u>
- ❖ <u>Discuss and Vote on Safe Schools Policy Revision B</u> Debby explained that the school received a notice that the school needed to include e-cigarettes in all anti tobacco policies which are included in the Safe Schools Policy. It has been discussed that every time there is an opportunity to update a policy we will separate the policy from the board policy which gives direction and the procedures which is under the management of administrative policy. The Safe Schools Policy has been amended to reflect this. Debby stated that the e-cigarettes will be included in the administrative policy portion of the Safe Schools which does not require board approval. Debby will be presenting the administrative policy to the community council to review. **Jennifer Bazzano made a motion to approve the Safe Schools Policy Revision B. Motion passed unanimously.**
- ❖ <u>Discuss and Vote on Spain Airfare & Tuition</u> Debby stated that there are (41) students going to Spain. This is the year that the students that started in kindergarten are in the ninth grade. More than half of the ninth graders are going to Spain. Since there are more students this year, the cost has increased as well. Dawn asked if the board would like to do a "not to exceed amount". Jennifer Bazzano made a motion to approve the expenditures for the Spain Study Abroad trip not to exceed \$115,000. Motion passed unanimously.
