

## Dear NDPA Families,

NDPA has made many changes to the scheduled days in school. To accommodate these changes our kitchen staff have also made changes in the lunch program to help meet your needs.

It is our desire to continue to provide quality nutritious meals to help make lunchtime easier. Please read over the options below that are available to your student(s). We will start serving students next week, which will allow you to pre order for your students THIS WEEK.

**Meal Pricing** will remain the same this year! We know with everything going up in price, a nutritious, well balanced, and safely prepared meal may help ease some of the extra burden you are experiencing.

- 7-9 Grade: Full \$2.40 Reduced \$0.40
- 1-6 Grade: Full \$2.00 Reduced \$0.40

**Applications** are available through your parent Aspire login for free and reduced meals, or you can pick up a paper application in the office.

**Gluten Free:** If you have a child that needs a Gluten Free menu, please let me know if they are A or B days and in what grade so we can provide them an option. *GF sack lunches may vary from regular menu sack lunches.*

### **HYBRID STUDENTS**

**Each day of attendance**, hybrid students will have the opportunity to purchase a hot meal that will be served in the cafeteria.

**Each Monday for A day students or Tuesday for B day students**, students will place an order with their teacher for the following week's lunches if they would like to have sack lunches to take home for their non-attending school days for the week. These meals will be given out at the end of the day on the days they attend.

**EXAMPLE:** *My child is in school on A days. On Monday, they will bring home Tuesday's lunch; on Wednesday, they will bring home lunch for Thursday (and Friday if applicable) lunch.*

### **ONLINE ONLY STUDENTS**

Your child can still participate in the School Lunch Program! **Meals for online only students need to be pre ordered.** Fill out the order sheet below and bring it to the school when you pick up your meals, or email it to [Jgypp@northdavisprep.org](mailto:Jgypp@northdavisprep.org) no later than 3:00 pm on Friday for the following week's meals.

Pickup days are Mondays & Wednesdays in the front of the Jr. High Building, from 1:00-1:30 PM.

On Monday you will receive meals for Tuesday & Wednesday; on Wednesday you will receive meals for Thursday, Friday, & the following Monday.

**No school lunches will be provided for scheduled "no school" days.**

**NOTE:** *If you order meals, you will be charged for them unless you cancel at least 24hours in advance. Any meals that have been ordered but not picked up will still be charged to your account.*
